

Indiana Michigan Power Rebate Requirements

- Applicant must be an Indiana residential customer of Indiana Michigan Power.
- All rebated products must be listed by the EPA as ENERGY STAR® certified on www.energystar.gov.
- Maximum of two pool pump rebates per I&M account.
- Rebate applications are valid for qualified appliances purchased and installed by December 14, 2017.
- Application must be submitted within 60 days of purchase and installation to qualify for rebate.
- Rebate application must be received by December 14, 2017.
- Rebate application must include a valid I&M customer account number and be accompanied by a **legible copy of the dated sales receipt/proof of purchase that includes brand/manufacturer, model number, store name, purchase price and date of purchase.**
- Individual product rebate cannot exceed purchase price.
- Payment will be issued to the account holder and mailing address on record with the utility.
- Please allow up to 45 days from the date all required information is received to process your rebate.
- All rebated products must be used at the service (install) address listed on the front of this rebate application.
- Program procedures, requirements and rebate levels are subject to change or cancellation without notice and are subject to available program funds.
